# Facts about Osgoode Hall Law School of York University

## Programs

Osgoode Hall Law School is the largest common-law law school in Canada with about 900 students enrolled in its three-year Bachelor of Laws (LLB) Program. The School also has a highly regarded Research Stream Graduate Program in Law leading to Master of Laws (LLM) or Doctor of Philosophy (PhD) degrees. Osgoode Professional Development, which operates out of its own centre in downtown Toronto, offers numerous specialized part-time LLM Programs as well as Continuing Legal Education courses.

## History

Founded in 1889 when students enrolled in classes held at Osgoode Hall in downtown Toronto, the Law School became affiliated with York University in 1968 and moved into its current premises on the York campus in northwest Toronto in 1969.

## Faculty

Osgoode has an internationally renowned faculty of more than 55 full-time professors, and also draws upon the Toronto Bar for the most impressive group of adjunct professors in the country. In recent years the Law School has added to its faculty strength by hiring a number of new professors, including a Canada Research Chair and two named Chairs. In addition, the School has revamped its admissions policy and curriculum, and become the proud new home of the Law Commission of Ontario.

## Our New Building

Through a record \$78 million in private funding, alumni giving and government support, we have transformed our learning environment, our programs and our student financial support. In the fall of 2011 we will open the doors of our newly renovated and expanded building. Our Grand Reopening Celebration will take place on Sunday, October 16, 2011 from 2 to 5 p.m.

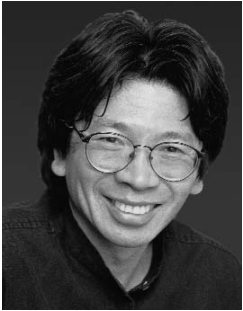
## Alumni
