🌢 MESSAGE FROM THE DEAN

Thanks to the hard work, energy and dedication of our faculty, students, staff, alumni and friends, the 2015-2016 fiscal year ending April 30 was vibrant and memorable. Across research, teaching and outreach activities, the Law School advanced our three key strategic objectives: the exploration of law in action, research intensification, and engagement in the community.

Some of the noteworthy initiatives which defined this year include:

- We extended the Law School's engagement with visual advocacy, welcoming two remarkable documentary filmmakers as Artists in Residence, and launching the Fund for Innovation in Law and Media (FILM) to create and sustain experiential education programs focused on the use of visual advocacy;
- We welcomed a range of new experiential opportunities for Osgoode students, including the launch of the Environmental Justice and Sustainability Clinical Program (EJSCP), the Feminist Advocacy clinical initiative with the Barbara Schlifer Commemorative Clinic; the Refugee Sponsorship Support Program (RSSP) Directed Research Project involving pro bono legal supports for the sponsorship of Syrian refugees, and the Community Organizing and the Law Project. At the same time, CLASP launched its newest division focused on employment law and Faculty Council approved the new International and Transnational Law Intensive Program (ITLIP);
- We enhanced our commitment to accessibility in legal education through the revamped Access to Law and Learning (ALL) program, for high potential/low income undergraduate students interested in preparing for the LSAT and legal education; and through the implementation of the Income Contingent Loan Program (In this three-year pilot program focused on financial accessibility, five eligible JD students a year will be offered admission to the Law School on an income contingent loan repayment basis.);
- We also demonstrated our commitment to preparing Osgoode students for success through the launch of the Learning & Leading Series of professional development programs for Osgoode students; and
- As part of several initiatives aimed at deepening Osgoode's commitment to Indigenous communities, we introduced an Honour Ceremony for Indigenous graduates as part of Spring Convocation celebrations.

In 2015-2016, the Law School continued to make strides in all of our academic programs, especially in providing more services and programming through digital platforms. The JD Syllabus, for example, was available to students for the first time via the Osgoode website, making it easier and quicker for them to search for courses and course updates. OsgoodePD's fully online NCA Exam Prep Course was launched in the summer of 2015 (with generous support from the Government of Ontario) and attracted even more students than anticipated. As well, the Osgoode Digital Commons – now the repository for all scholarship produced by Osgoode's faculty – continued to expand and grow.

It was also a year of important milestone anniversaries. OsgoodePD celebrated its 20th anniversary with a communications campaign featuring the stories of 20 people involved in OsgoodePD over the last 20 years, special panel discussions, and an appreciation reception. In addition, Osgoode marked its 50th year at York University with, among other things, an Osgoode research celebration called "The Power of Collaboration." The Osgoode/York @50 Fund of \$50,000 supported a number of ground-breaking, interdisciplinary conferences, symposia, and projects.

Members of our community were recognized for a variety of achievements, ranging from teaching to service. Associate Dean Research Carys Craig was presented with the 2015 President's University Wide Teaching Award. Professor Deborah McGregor was awarded the Tier 2 Canada Research Chair for her research in advancing the theory and practice of environmental justice scholarship by engaging with Indigenous intellectual traditions. Professor Stepan Wood was awarded a Tier 1 York Research Chair in Environmental Justice and Sustainability.

Our faculty, staff and students have been recognized for their outstanding contributions in numerous settings. Professor David Vaver was inducted into the Order of Canada. Professor Emeritus Fred Zemans and Visiting Professor Ronda Bessner received a Law Society of Upper Canada Medal. Visiting Professor Fay Faraday was awarded the Spirit of Barbra Schlifer Award by the Barbra Schlifer Commemorative Clinic. As well, the Osgoode Black Law Students' Association (BLSA) and Visiting Professor Jamil Jivani were each honoured with a Lexpert Zenith Award for excellence and service in the field of Diversity and Inclusion, along with Visiting Professor David Lepofsky (who also received an Honorary Doctorate from the Law Society of Upper Canada).

This Annual Report offers many more illustrations of the accomplishments of 2015-2016. Thank you again to the members of the Osgoode community for your contributions to the Law School's strong performance. I look forward to working with you to build on these accomplishments in the coming year.

ADMISSIONS & STUDENT SERVICES (JD)

• HIGHLIGHTS

- As of July 1, 2015, the role of the Associate Dean, First Year was subsumed into the new Associate Dean (Students) position, which has responsibility for oversight of all student matters at the Law School. The inaugural Associate Dean (Students), Professor Benjamin Berger, works closely with the Office of Admissions & Student Services staff to provide support and resources to assist in easing the transition into law school for first- year students and encourage the academic success of all students in the JD program. The Associate Dean (Students) administers the Academic Success Program, which consists of panels, presentations and programs designed to assist students in various aspects of the academic experience at law school. This year, the Associate Dean (Students) delivered nine Academic Success sessions for students, ranging in topics from *Class Preparation, Note-Taking and Participation Skills* to *Electronic Communication Skills* and *How to Approach & Understand Your First -Year Grades.* The Associate Dean (Students) also has oversight of the Dean's Fellows program and works closely with the Student Success and Wellness Counsellor on initiatives aimed at supporting the mental health of students.
- In the fall of 2015, the Student Financial Services Office implemented Osgoode's Income Contingent Loan Program (ICLP), an important initiative in promoting the financial accessibility of legal education. In each year of the pilot program (2015-2018), Osgoode will select five eligible incoming students to participate. Recipients receive bursary and loan funding to cover the entire cost of tuition for the duration of their JD degree. They will agree to repay the entirety of their Ioan after graduation over a 10- year period. Contingent on their income level in any of the years of the repayment period, the loan repayment for those years may be forgiven in whole or in part. Typically students will apply to the ICLP when they apply to law school and Osgoode will select the recipients before the deadline for responding to Osgoode's offer of admission. This allows students to decide whether to accept Osgoode's offer of admission with the knowledge of whether they have been accepted into the ICLP. This year, because the ICLP was implemented after the 2015 JD application deadline, first- year students were eligible to apply to the ICLP in the fall. In November, five current first -year students were selected to participate in the program by a subcommittee of the Admissions Committee. In March, an additional five recipients were selected from the group of applicants accepted to start the JD program in September 2016. All five accepted Osgoode's offer of admission.
- The Office of Admissions & Student Services has been making strides to provide more services to students online. This year, the JD Syllabus was, for the first time, available to students via the Osgoode website. This allows students to quickly and easily search for courses and course updates can be communicated to students in real time. Additionally, students can now access course evaluation results entirely online.

● STUDENT SUCCESS AND WELLNESS

The third year of operation for the Student Success and Wellness office continues to be a valuable service for the student body. Under the direction of counsellors, Melanie Banka Goela and Ellen Schlesinger, the demand for individual counselling service continues to grow year over year. In the 2015-2016 academic year, 132 JD students received individual counselling services, which is a 25 percent increase in students served since the program's inception in 2012-2013. Consistent with previous years, the main presenting issues include anxiety, depression, disability, and relationship challenges/breakdown and the intersection between these and students' academic experience. Students were seen by the counsellor, on average three times, with some students benefiting from a single session and others benefiting from upwards of 15 sessions, depending on individual circumstances. In addition, a number of JD students who did not present for individual counselling also received wellness information and support by attending mindfulness sessions or attending a group workshop or mental health event.

The Student Success and Wellness office has also led a number of innovative initiatives over the last few years. Highlights from 2015-2016 include leading the expansion of justbalance.ca from an Ontario- based support site to a national site, with nine new partner law schools outside of Ontario now participating. In addition, under the office's mandate to integrate mental health and wellness support within other services at the Law School, the counsellor collaborated with the Associate Dean(Students) to offer new wellness programs and trainings to students.

🗴 GRADUATE STUDIES PROGRAM IN LAW

HIGHLIGHTS

- Under the direction of Professor Dayna Scott, the Graduate Program in Law graduated 20 students in 2015-2016, all of whom are making a mark furthering their careers teaching in law schools and other advocacy and leadership positions throughout the world.
- New professional development workshops were developed both for students who seek to enter legal academia after their studies, and for students interested in the world beyond academia, including advocacy and policy positions at international organizations and institutions, think tanks, and in various government departments.
- A new Writing Tutor position was established in order to provide excellent mentorship and supervision training to our top doctoral students.
- · Graduate students won an astounding number of prestigious scholarships and awards.
- For example, PhD student Zachary Lomo was awarded the Vanier Scholarship to further his
 research into legal liability for the environmental impacts of refugee camps in Kenya and his native
 Uganda. The Vanier supports world-class doctoral students who demonstrate both leadership skills
 and a high standard of scholarly achievement.
- Our students received Social Science and Humanities Research Council awards totaling \$270,000. Current PhD student Dana Phillips received the York University Faculty of Graduate Studies Thesis Prize for her LLM thesis entitled, "Let's Talk About Sexual Assault: A Feminist Exploration of the Relationship Between Legal and Experiential Discourses." This is the second year in a row that an Osgoode LLM student has been awarded this university-wide honour.
- Students once again participated in the Association of Transnational Law Schools (ATLAS) Agora, which was held at Bucerius Law School in Hamburg, Germany from June 6 to 17, 2016. ATLAS is an association of law schools with a transnational outlook, and the Agora is an intensive threeweek exchange of ideas and perspectives which provides our students with valued input on their research projects from top legal scholars from around the world.
- In addition, the Graduate Program provided a total of \$5,000 in funding to assist our students in attending academic conferences in their fields, including in Calgary, Los Angeles, Dunedin, New Zealand and Sri Lanka.
- The Annual Graduate Student Conference was held in February 2016 and featured a keynote address by Professor Elizabeth Mertz, a founding figure in the field of New Legal Realism. The conference was a tremendous success attracting students from many universities across Canada and beyond, involving faculty members on panels and as discussants, and giving the students the opportunity to share their research with peers, as well as engage socially together in Toronto.

• OSGOODE PROFESSIONAL DEVELOPMENT

• HIGHLIGHTS

- **OPD celebrated its 20th anniversary** with a communications campaign featuring the stories of 20 people involved in OPD over the last 20 years. We held special panels for alumni on topics including:
 - State of the (Oil) Nation: What's in the Pipeline?
 - Physician-Assisted Dying in Canada: Where Do We Stand One Year after Carter?
 - Advocacy & Political Dissent: How Do We Safeguard the Independence of Canada's Watchdog Institutions?
 - We also held an appreciation reception to celebrate with our founders, staff, instructors, suppliers and York supporters on this important milestone.
- The LLM in Canadian Common Law, launched in the fall of 2013, continued to be popular with enrollment exceeding our expectations by close to 30%.
- The nine month **Pre-LLM Foundations** program to help prepare international law students for Professional LLM Programs was launched successfully in Fall 2015. The program is a partnership with York University English Language Institute.
- The fully online **NCA Exam Prep Course** was launched in Summer 2015 and attracted more students than anticipated. This program was funded by the Province of Ontario to assist newcomers with international law degrees to become accredited to practice in Ontario.
- We **extended our lease at 1 Dundas** for a further 10 years until January 31, 2028, with an additional five-year option to renew. At the same time, we prepared to move some of the classes for full-time LLM students to the Osgoode building to accommodate growth in the programs and provide better access to services for students.
- We exceeded both our revenue and net contribution targets for the year.

PROFESSIONAL LLM

- Professional LLM (excluding the LLM in International Business Law and Canadian Common Law programs) enrollment averaged 294 students per term.
- · 29 students from 23 different countries were enrolled in the LLM in International Business Law.
- The LLM in Canadian Common Law program had on average 97 students per term of which 60% were full-time and 40% part-time.

● NON-CREDIT CONTINUING LEGAL EDUCATION

- 5,332 delegates participated in the non-credit programs, with approximately 60% attending in person and 40% online.
- New short courses included: The Intensive Short Course in Structuring, Negotiating & Drafting Entertainment Contracts; Real Estate Disputes: Practical Advice for Civil Litigators; The Civil Litigator's Survival Guide to Evidence; Residential Landlord-Tenant Disputes: Essentials for Advocates; and, Courtroom Testimony: A Practical Skills Workshop.
- 25 multi-day certificates were offered. Newly launched certificates included Fundamentals of Aboriginal Law, Negotiating and Drafting IT Agreements and Public Private Partnerships.
- 77 online replays were conducted with 238 delegates participating as well as 13 standalone webinars with 873 delegates.
- Custom and in-house programs were delivered to several organizations including the Ontario Securities Commission, the University of Toronto, the City of Ottawa, Fidelity Canada, and a consortium of Manitoba organizations.
- Total CLE revenue was up from previous fiscal by almost 5%.

OSGOOD

• STAFF

Michele Francis, the Library's Acquisitions Assistant, was awarded Osgoode's Louella Sturdy Leadership Award as recognition of her work and example. All of Michele's colleagues in the Library were thrilled by this acknowledgement.

Susan Ewing, formerly library director at the Canadian National Institute for the Blind, who started in January 2015 as our Manager, Library Operations, on a one-year contract, became permanent in November 2015. Susan has already made a significant and positive impact on the Library's operations and development.

Jordan Patterson, who started as our cataloguer on a part-time basis in September 2014, became fulltime in April. Jordan's specialization in rare books has been a boon to managing and documenting our special collections.

BUDGET AND COLLECTIONS

The Osgoode Library's operating budget was cut by 2.5% in the past year, while an increase of 1.5% to the acquisitions budget (also for the coming year) did not begin to address the price increases from publishers, which significantly exceeded CPI. The sharp decline in the Canadian dollar's foreign exchange value in the past year further negatively impacted the acquisitions budget. However, as a result of the proactive cancellation of many print subscriptions and a strict evaluation of the use of many online subscriptions, begun in previous years, we were well placed to weather the consequences. We actually finished the year with a surplus, which we have been able to roll over into next year's acquisitions budget.

Acquisition of monographs remained robust, and 1,346 new titles were added to the collection. The acquisition of special and rare materials also remained strong: 288 titles, primarily Canadian, were added to the Balfour Halévy Special Collections.

• E-RESOURCES

This year, the Osgoode Library took out a campus-wide subscription to WestlawNext Canada (LawSource, CriminalSource and LabourSource), allowing access to the digital versions of all Carswell law reports as well as **The Canadian Abridgment**, the **Canadian Encyclopedic Digest** and other important legal materials for everyone at York University.

The only "new" major e-resource acquired this year was the Brill <u>Encyclopedia of Law and Religion Online</u>, an excellent resource for this rapidly developing area of research.

● RARE BOOKS AND SPECIAL COLLECTIONS

Working with the Library Committee, the Library began a review of its collection development policy for the Balfour Halévy Special Collections. The first draft has been circulated and comments received. We hope to complete and publish the new policy in the coming year.

In the past year, most of our special acquisitions were early statutes, pamphlets and broadsides, filling some of the holes in our already significant collection of early legal Canadiana. Though important, none of these acquisitions were especially exciting, with the following exceptions:

- We enhanced our collection of books from the 19th-century <u>Jarvis-Irving Library</u> (<u>Samuel P. Jarvis,</u> <u>1792-1857</u>, and his daughter-in-law's brother, <u>Aemilius Irving, 1823-1913</u>) with the addition of a further 33 titles (50 volumes). This is a unique reconstruction of a 19th-century Canadian lawyer's personal law library.
- We acquired a copy of the rare trial pamphlet <u>The Confession of Joseph Baker, a Canadian by Birth,</u> <u>for Murder & Piracy Committed on the High Seas</u>, published in Philadelphia in 1800. This is the only copy in Canada. The acquisition was made possible by a gift from the Osgoode Class of 1955. The acquisition and the gift were recognized in a post on our rare book blog.
- We acquired a collection of rare early New Brunswick sessional statutes, for the years 1794-1800.
- For our Trials collection, we acquired copies of both the <u>Fredericton</u> and <u>Montreal</u> imprints both rare, especially the Fredericton imprint of the pamphlet Life and Confession of Sophia Hamilton, who was tried, condemned and sentenced to be hung for the perpetration of the most shocking murders and daring robberies perhaps recorded in the annals of crime (1845). Editions of this completely bogus and fictional work were also published in New York, Philadelphia and Boston, each reporting that Sophia was tried, condemned and hung in that city. She was one busy bad girl!

You can read the pamphlet online on the Internet Archive.

One of the goals of our rare book collection is to acquire for Canada copies of the major classics of the Common Law. Among these "legal classics" one must include the medieval and early Tudor <u>Year Books</u>. As the year closed, we acquired (but have not yet catalogued) a collection of the first-edition year books covering the reigns of Edward V through Henry VIII.



● OSGOODE DIGITAL COMMONS

Osgoode remains the only law school in Canada with a faculty institutional repository. Our Osgoode Digital Commons continues to expand and grow. It is now officially the repository for all scholarship produced by Osgoode's faculty. At the end of this reporting year, there were almost 15,000 documents in the repository and there had been almost 810,000 full-text downloads from the repository since its inception two years ago.

In the summer of 2015, bepress, the producers of the Digital Commons software platform on which Osgoode Digital Commons is built, conducted a benchmarking study of law school repositories built on their platform. Osgoode Digital Commons ranked in the top five in two of the three categories, specifically, for steady growth of the repository and the variety of materials documented in the repository. We are extremely proud of this achievement and recognition.

LIBRARY OUTREACH - ART IN THE LIBRARY

Since the renovated building opened four years ago, it has been the Library's goal to host a special, lawrelated historical or artistic exhibition in each term. We have been lucky to be able to do this consistently, and extremely fortunate this past year to host two outstanding exhibitions.

In the Fall Term 2015, we hosted the highly acclaimed international exhibition <u>Lawyers Without Rights:</u> <u>Jewish Lawyers in Germany Under the Third Reich</u>. The exhibition was prepared by the German Federal Bar (Bundesrechtsanwaltskammer), and was translated into English and prepared for exhibit in North America by the American Bar Association. The exhibition at Osgoode was sponsored by the Jack & Mae Nathanson Centre on Transnational Human Rights, Crime & Security. The exhibit was shown in nearly 100 cities in Germany, the United States and other countries: the Osgoode Library was the only Canadian venue for the exhibit.

In the Winter Term 2016, we hosted the <u>Treaty Canoe</u> performance/sculpture/art installation. As a collection of objects dealing with art and law, tool and text, and past and present, **Treaty Canoe** is at once an important recognition of the violence and erasure at the foundation of the colonial project in Canada as well as an invitation to participate in a de-colonial 're-writing' of these histories.



• OFFICE OF RESEARCH & INSTITUTIONAL RELATIONS

• HIGHLIGHTS

This report showcases the achievements of the Associate Dean Research, Carys Craig, and the Research Office in 2015-2016. The Research Office continues to successfully implement Osgoode's Strategic Plan as it relates to research, and carries out the mandates of the ADR. Some highlights from the year include:

- Osgoode's Research Celebration "The Power of Collaboration" was held in November 2015 to showcase faculty and student research initiatives, celebrate recent faculty academic promotions and appointments, and to mark Osgoode's 50th year at York University. Panels were convened on "The Power of Collaboration" and "The Collaboration of Power."
- In fall 2015, the Research Hub was officially launched. This space, which occupies the former CRL offices, now houses post-doctoral researchers, Visiting Scholars and Researchers, Osgoode Artists-in-Residence and the Media Innovation Creativity Lab.
- Professor Deb McGregor was awarded the Tier 2 Canada Research Chair for her research in advancing the theory and practice of environmental justice scholarship by engaging with Indigenous intellectual traditions. Her research seeks to develop a distinctive environmental justice framework based on Indigenous knowledge systems and the lived experience of Indigenous peoples.
- Professor Stepan Wood has been awarded a Tier 1 York Research Chair in Environmental Justice and Sustainability. His research program explores transnational sustainability governance schemes from a transdisciplinary perspective, seeking to these interactions to empower marginalized interests and advance sustainability.
- Associate Dean Research **Carys Craig** was presented with the 2015 President's University Wide Teaching Award.
- In April The Annual Constitutional Cases Conference, organized by Professors Benjamin Berger and Sonia Lawrence was an outstanding success, and included a keynote address by The Honourable Justice Richard Wagner of the Supreme Court of Canada.
- PhD student Sheila Jennings received a prestigious Social Sciences and Humanities Research Council (SSHRC) Postdoctoral Fellowship that provides two years of federal funding (\$81,000 in total) to assist with her postdoctoral project entitled "Becoming Aware: An Exploration of Legal and Critical Consciousness with Mothers with Disabled Children."Post-Doctoral Fellows Dr. Sagi Peari and Dr. Adelina Iftene were recommended to the SSHRC by the ADR as outstanding candidates for post-doctoral funding. Both were successfully granted financial support to pursue post-doctoral studies at Osgoode, commencing in 2015.
- Post-Doctoral Fellows Izevbuwa Kehinde Ikhimiukor (PhD, Middlesex University), Shiri Pasternatk (PhD, University of Toronto), and Rebecca Schmidt (PhD, European University Institute) were welcomed to Osgoode to pursue post-doctoral studies, commencing in 2015 -2016.
- Dr. Sarah Hamill, (LLB (Glasgow), LLM (U of T), PhD (Alberta), was resident as the **Osgoode** Catalyst Fellow 2015-2016.
- Osgoode entered into a new Student and Faculty Exchange Agreement with the University of Aruba, Faculty of Law. The student exchange program with Trinity College, Dublin, was amended to enable Osgoode students to earn a Master in Laws degree from the University of Dublin during their exchange year.



HENNICK CENTRE FOR BUSINESS AND LAW

The Hennick Centre for Business and Law, a joint initiative of Osgoode Hall Law School and Schulich School of Business, is the first Canadian centre to promote and develop joint business and legal scholarship and education. By combining the strengths of the world-renowned law and business schools at York University, the Hennick Centre delivers innovative programs and initiatives for students, scholars and practitioners alike at the intersection of law, business and public policy.

• HIGHLIGHTS

- Hennick Summer Internships prepare Osgoode students for the world beyond law school by exposing them to the real world nature of problem-solving and the client side of legal practice. This year the Centre expanded its business law-focused summer internship program once again by introducing a new placement opportunity to the students in the sphere of international world affairs. This summer our students are enjoying the following placements: (1) Mount Sinai Hospital, (2) Ontario Securities Commission (OSC), (3) the Centre for Addiction and Mental Health (CAMH), and (4) NATO Council of Canada.
- Osgoode Venture Capital Clinical Project (OVC), a partnership between the Centre and Wildeboer Dellelce LLP, has completed its second successful year. Eight Osgoode students worked throughout the academic year as caseworkers under the guidance and supervision of Wildeboer Dellelce lawyers, providing legal services to early stage entrepreneurial ventures in the financing and equity structuring stages of growth. The OVC was a new addition to Osgoode's business law-focused experiential education programs in 2014, and has been growing steadily ever since, gearing up for expansion to 14 caseworkers for the 2016-2017 term.
- LawWithoutWalls (LWOW) is an international academic program of the University of Miami's School of Law where students work with scholars, legal professionals and business experts from around the world to create a business plan in response to a problem in legal education or practice. The Hennick Centre sponsors the participation of Osgoode students in LWOW. This year we congratulate JD/ MBA student PJ Esfandiari for his successful participation in the program and winning the LWOW Team Award for Substance.
- Hennick Medal for Career Achievement is presented annually to a distinguished leader who has earned international recognition in the business and legal communities. The 2015 Hennick Medal for Career Achievement was awarded to Sergio Marchionne (LLB'83), Chief Executive Officer of Fiat Chrysler Automobiles and Chairman of Ferrari, during the VICO Lecture Series on November 17, 2015.
- Hennick Medal for Academic Excellence recognizes the top graduating student in the JD/MBA program. The 2015 Hennick Medal for Academic Excellence was awarded on February 5, 2016 at the JD/MBA Student Conference to Liane Langstaff who during her studies, focused on environmental, aboriginal and corporate law. Langstaff has subsequently completed her articling with Gowling WLG's Toronto office, through an intensive rotation in the Business Law and Environmental departments.

- The 2015-16 Davies Business Law Lecture entitled "Shareholder Wealth Maximization On Steroids: Do the Brakes Still Work in Corporate Governance?" was presented by Professor John C. Coffee Jr., the Adolf A. Berle Professor of Law at Columbia University Law School and Director of its Center on Corporate Governance. Prof. Coffee is a Fellow at the American Academy of Arts and Sciences and has been listed repeatedly by the National Law Journal as among its "100 Most Influential Lawyers in America." His lecture was attended by over 100 Osgoode students and guests.

Graduate Students

In August, 2015, Dana Phillips took on the new role of IFLS Graduate Fellow. She also organized and hosted monthly "Shut Up and Write" sessions in the IFLS space throughout the year, geared towards building a feminist student community associated with the IFLS and supporting student research and writing. A number of graduate and JD students attended these sessions, as well as the occasional faculty or other staff member. In the winter semester, Phillips started a new iteration of the IFLS book club with the help of a core group of graduate students. The book club, which includes JD students, graduate students, faculty members, and an Osgoode artistin-residence, met on a monthly basis starting in January. In addition to regular postings about events and community news, contributions to the IFLS blog included an in-depth interview with a visiting feminist scholar, and a new series of guest posts featuring the work of graduate and postdoctoral feminist scholars at Osgoode. As a student liaison, Phillips has also started to build connections with the Osgoode Feminist Collective. In future years, the IFLS Graduate Fellow could extend relationship-building efforts to other feminist student organizations at York. Overall, the position creates opportunities to cultivate and deepen connections with the feminist student community at Osgoode and beyond.

● SEMINARS/LECTURES/SPECIAL EVENTS

For the ninth year in a row, NC organized its now world-renowned seminar series on "Legal Philosophy between State and Transnationalism," which continues to be co-hosted by Professor Michael Giudice and Professor François Tanguay-Renaud. The year's seven speakers were Professor Kerah Gordon-Solmon (*Queen's University*, "Killing as a side-effect in self-defense"), Professor Helen Frowe (*Stockholm*, "Reductive individualism and the just war framework"), Sagi Peari (*Post-Doc, Osgoode*, "Can better law be married with corrective justice or evil laws?"), Professor Lorenzo Zucca (*King's College London*, "Rethinking secularism in Europe"), Professor Arash Abizadeh (*McGill*, "The special-obligations challenge to more open borders"), Professor Stefan Sciaraffa (*McMaster*, "Political Authority: Its collectivist structure and juridical ground"), and Professor Hans Lindahl (*Tilburg*, "Collective action and emergent global legal orders"). All these events were well attended, with audiences ranging from 15 to 40 people.

The Centre also hosted a number of guest seminars and public lectures, starting with talks delivered by Professor Tarunabh Khaitan (*Oxford*, "The Public-Private Divide in Discrimination Law"), John Weigelt (*Microsoft Canada*, "Adjusting the change frame of reference of our technology (from a cybersecurity standpoint)", and Professor Sarah Knuckey (*Columbia*, "Righting Wrongs: Barrick Gold's Remedy Mechanism for Sexual Violence in Papua New Guinea"). Professor Jean-Gabriel Castel (*Emeritus*, *Osgoode*) delivered a Distinguished Nathanson Lecture on "Fully Autonomous Artificial Super-Intelligence: Is it a Threat to the Human Race or a Blessing? How can it be Controlled?" In a special public lecture (the Sivalingam Lecture), organized by NC in collaboration with the York Centre for Asian Research (YCAR), former United Nations High Commissioner for Human Rights, Dr. Navi Pillay, spoke on "Accountability and Justice for International Crimes: Challenges and Achievements." Professor Cheyney Ryan (*Oregon/Oxford*) delivered the 2016 'Or 'Emet Lecture on "Pragmatism and vision in conflict resolution and peacemaking."

To commemorate the 70th Anniversary of the start of the Nuremberg Trials, NC hosted a special exhibition on "Lawyers Without Rights: Jewish Lawyers in Germany Under the Third Reich." This exhibition, sponsored by the American Bar Association and German Federal Bar, made its Canadian debut for the occasion, and was on display for three weeks in the Osgoode Law Library. A panel of experts comprised of Mélanie Deshaies (*Doctoral candidate, Osgoode*), Eric Gertner (*Ryerson/McCarthy Tétrault*), Hengameh Saberi (*Osgoode*), and Lorne Sossin (*Osgoode*), kick-started the commemoration by focusing on the theme of "Nuremberg at 70: Commemorative Panel on the Implications of the Trials for Legal and Medical Ethics."

In collaboration with Glendon College, and under the leadership of Professor Ellen Gutterman, the Centre also organized a special screening of the documentary "Hyena Road", followed by a discussion with its writer and producer Paul Gross and associate producer Lt. Ted Howard.

• CONFERENCES

In 2015-2016, the Centre organized three major international conferences/workshops:

- An international conference on "Educating for Integrity," focusing on the theme of anti-corruption (November 5 to 7, 2015), hosted in collaboration with the Canadian Business Ethics Research Network (CBERN) and the Central European University. This conference brought together over 35 anticorruption experts from around the world at Osgoode, and involved the active organizational role and presentations of several NC research associates, including Professor Margaret Beare, Professor Ellen Gutterman, and Professor Ron Atkey.
- 2. An international conference on **"The Legitimate Ambit of Domestic and International Criminalization"** (April 1 to 3, 2016).

This conference, organized in collaboration with the Robina Institute for Criminal Law and Criminal Justice at the University of Minnesota, brought together over 20 experts on the theory of domestic and international criminal law, who were asked to address cutting-edge themes related to the process and substance of criminalization. Professor François Tanguay-Renaud and Professor Neha Jain (Minnesota) were the main organizers, and Osgoode Professors Benjamin Berger, Lisa Dufraimont, Palma Paciocco, and Dan Priel also actively participated.

3. A workshop on "African Faith-Based Activism in Canada and the Western World: Law, Politics, and Socio-Economics" (April 29, 2016).

This workshop, organized by Professor Obiora Okafor, brought together leading intellectuals and practitioners in law, political science, theology, sociology, and anthropology to address the ways in which African religious movements have shaped or affected Western states and society and implications for theories on the relationship between the global North and the global South. Many NC research associates were involved, including Professor Benjamin Berger and Director François Tanguay-Renaud.

VISITING AND POST-GRADUATE FELLOWS

NC welcomed Professor Helen Frowe (*Stockholm/Stockholm Centre for the Ethics of War and Peace*) as a Visiting Fellow this year. She presented her evolving work on Just War Theory, and participated in related activities at the Centre. Professor Alan Clark (*Utah Valley*) also completed a visit he had begun the previous year.

The Centre also welcomed a number of Post-Doctoral Fellows. Dr. Emmanuel Guématcha, who had been a Fellow at the Centre for the past two years, continued his residence until he was appointed to a permanent position at the Université de Guyane in French Guyana. Dr. Elizabeth Kirley also spent the year in residence after completing her doctorate at Osgoode under the supervision of Professor Margaret Beare.

MEDIA INNOVATION AND CREATIVITY LAB (M!C)



- Technical video and audio support for Professor Faisal Bhabha. An ongoing historical research documentary.
- Process re-engineering and technology update project to allow more student access to the M!C facilities and media production.
- Closed-captioning research and testing for Osgoode AODA video compliance. IBM partnership to use artificial intelligence.
- Provided training and technical facilities for student research projects.
- Various teaching archive projects including a multimedia project with Professor Liora Salter.
- Designed and engineered the technical aspects of the Indigenous justice conference.
- Ongoing training of Corporative Student from Seneca, Osgoode Student, Faculty, Artist in Residence, Post Docs and Fellows.



INFORMATION TECHNOLOGY SERVICES

- **Streamlined service delivery** for course websites and business applications. This resulted in faster and better service for requests related to these services. More of the support ran through the Helpdesk, resulting in a higher number of tickets for this year, but faster service.
- The Helpdesk **resolved approximately 8,700 service tickets** within the last year approximately35 service tickets per business day.
- Implemented a formal **Change Management policy** to improve communication with the community and reduce down time of services such as email, websites and content changes.
- · Increased email support for mobile devices (i.e., Android OS5.1.1 & OS9.3.2 is now supported)
- Faculty & Staff **Mail system clustering** has been created to improve mail redundancy to ensure the uptime of critical business systems of the Law School.
- Osgoode's Media Server is currently storing over 2,120 GB of data, consisting of roughly 32,941
 Audio/Video files, including historical content, such as pictures and excerpts.
- During the 2015-16 academic year, there were **2,787 published Lecture recordings**.
- There were a total of **52 combined video conference events** this year, up from 17 last year. These events included PhD defences, guest speakers, research conferences, etc.
- Of the 52 video conferencing events, **28 Professional Video Conferences** had been streamed online throughout the world.
- Osgoode has drastically increased the amount of Microsites it's hosting to 30 separate sites, which includes; 7 Blogs, 6 Research, 4 Application, 3 Teaching, 7 Research & Teaching, 2 Websites and 1 Portal.
- **Upgraded all of Osgoode Moneris Card Payment Terminals** to ensure that we are compliant with the utmost strict [PCI-DSS] Payment Card Industry Data Security Standards.
- Dean's Scribes program has been **redesigned and simplified** to allow for quicker processing of requests for students requiring accommodations
- MyJD, Osgoode's **Degree Tracking System, was successfully launched**. It has had great feedback and praise by both the student community as well as students.
- Osgoode ITS continued the migration of key infrastructure components over to central York in order to manage our key servers and network components. This will increase reliability and responsiveness of the applications and websites that are stored on these servers. This also allows Osgoode to leverage shared resources within central York to further reduce operational costs.
- New Family Law Screening Module built in to the CLASP Client Management Tool. It permits
 Division Leaders and volunteers to screen callers to establish if they are eligible for CLASP
 services.
- Data security protocols have been updated once again this year. A new piece of software and other counter measures has been installed and configured on all of the Osgoode Servers that is designed to prevent malware, viruses and any threats to the integrity of data systems we host.

The 2016 fiscal year operating budget for the Law School supported the School's core teaching, learning and research activities over the 2015-16 academic year. The year ended with a \$3.1M in-year surplus, due in large part to Osgoode Professional Development's contribution of approximately \$2.5M towards the surplus.

The \$2.5M surplus generated from OPD programs has been directed as follows:

- \$266K will be added to the contingency fund;
- \$742K will be directed to support OPD infrastructure; and
- \$1.5M will be directed to fund strategic initiatives.

The School's in-year surpluses have been used to fund numerous projects and initiatives that support the School's strategic objectives (i.e., accessibility, research intensification, and experiential education). The projects and initiative supported by the 2016 fiscal year surplus include:

- · LSAT prep course for high potential/low income undergraduate students;
- Income Contingent Loan Program;
- · Debt relief bursaries (e.g., Wendy Babcock Bursary);
- · International Legal Partnership; and
- · Osgoode's Anishinaabe Law Camp.

In fiscal 2017 the School will have a \$7.8M carry forward from the 2016 fiscal year. This carry forward consists in large part of the funding for the five-year Income Contingent Loan Program pilot; the School's contingency fund that provides support for unplanned expenses, research grant commitments, and possible future in-year operating deficits that may occur during the transition to the new SHARP budget model; and commitments for initiatives set out in the School's strategic plan.

The 2017 fiscal year operating budget anticipates another in-year surplus. The overall financial position of the School is expected to remain positive in 2017 and it is expected that surplus funds generated from Osgoode's professional development programs in fiscal 2017 will add to the School's existing strategic initiatives and contingency funds.

MEMORANDUM

At Osgoode, mooting and skills simulations competitions are continuously growing in interest and popularity among students. Students enjoy participating in these competitions and the preparations leading up to them starting in first year. Mooting is one of the oldest traditions at Osgoode Hall Law School and it increasingly gains more vigour for students' desire to participate in garnering skills-based learning and experiential learning.

In the 2015-2016 mooting year, Osgoode did not win any overall mooting competitions. The two banners that will be hoisted in the west window of Gowlings Hall will be for the spectacular performance of Osgoode's negotiation team of Russell Hall and Veronika Stefanski, who first won the American Bar Association Regional Negotiation Competition, and then went on to take the championship title at the International Negotiation Competition, earning an unprecedented perfect score in the finals.

The failure to win a banner in in traditional moots fails to reflect the depth and breadth of Osgoode achievements in mooting this past year. In fact, Osgoode experienced far greater success than in the previous year. This was our first foray into the Price Media Law Moot. We were the runner-up team at the regional competition in New York City and qualified to advance to the international round in Oxford. At the Jessup, the team finished first runner-up, also winning second place memorials. This was a huge improvement after many years of Osgoode struggling at the Jessup. Last year we secured a fresh, committed team of highly skilled coaches who worked closely with the hard working students on the team. At the Diversity Moot, held in conjunction with the National Association of Black Law Students' annual conference, the team won best factum. Additionally, Osgoode finished in second place at three major competitions: The Bowman Tax Moot, the Wilson Equality Moot, and the Fox IP Moot.

The successes awarded at champions bring significant pride and joy to the school, which bolsters both general and mooting student morale and pride in the law school. Additionally, the advancements and winnings at competitions contribute to fostering Osgoode Hall Law School's reputation as an advocacy education leader. Yet, it is imperative to note that mooting and skills education mean more than simply winning competitions. Many benefits are derived from the mooting experience and Osgoode has remained committed to emphasizing learning over winning. Each mooting competition has a diverse array of awards that recognize different facets of the particular moots. Once more, Osgoode garnered a good deal of recognition.

Appended to this memo is a chart listing the 2015-2016 Osgoode moots and skills teams, members, coaches and results.

As we enter the 2016-2017 school year, there are many changes. In coaching, there has been some movement. Our coaches at the firm Olthuis Townshend have decided to no longer coach our Willms & Shier Environmental Law Moot team. Prof Dayna Scott and practitioner Lara Tessaro (who will be heading our environmental law clinic) have agreed to take on coaching responsibilities. This is a further step towards integrating full-time faculty in coaching responsibilities. The Diversity Moot will be moving from being coached by the African Canadian Legal Clinic, to the Human Rights Legal Support Centre. This is a result Roger Love's move from the ACLC to the HRLSC, and also of the deepening relationship between Osgoode and the HRLSC stemming from the Anti-discrimination Intensive. ADIP and the Diversity moot will gain from this relationship in mutually beneficial ways. In other developments, Brent Kettles, an Osgoode grad who has coached our Gale Cup moot team for several years, is stepping aside. He leaves the team in the very competent hands of an existing team of coaches comprised of Daniel Sheppard, Mabel Lai and Philippe Cowle.

When I began my tenure as mooting director in 2012, we had only one or two faculty members involved in mooting in any meaningful way. Bruce Ryder has been coaching the Wilson for many years, as did Janet Walker with the Vis. Since 2012, we have seen Allan Hutchinson coach the Niagara international law moot for a couple of years recently; Pina D'Agostino took the lead on our Oxford IP moot team for the last couple of years; Hengameh Saberi coached the Jessup team for a couple of years; Shelley Kierstead has been coaching the Walsh family law moot since its inception three years ago, and has also taken on coaching the Walsh family law negotiation competition. Last year, Jamie Cameron took on coaching the Price Media Law Moot, with Iris Fischer of the firm Blakes, and our team experienced great success.

We have also been working to harmonize rules and procedures with the needs of the program. For the last two years, the rule against competing in a moot and participating in a full-time intensive program in the same year has been enforced strictly, as has a similar rule with respect to university exchanges. The enforcement of these rules recognizes both that even the most skilled and competent students should not be over-stretching their commitments, and that mooting and clinical experiences are special and scarce, and thus deserve to be equitably distributed through the student population.

Due to an initiative of the Associate Dean (Students), a memo was issued last year clarifying our past practice and seeking to limit students' apparent growing expectation that they earn additional credit and be permitted to rearrange their academic schedules when victory leads them to additional rounds of competition. Associate Dean Berger's memo, clarifying that additional credit is only granted where a further round includes a fresh problem and writing requirement, has been distributed to all 2016-2017 mooters. Additionally, due to the hard work of Experiential Program Director, Kim Bonnar, and program assistant, Natia Tucci, the mooting reimbursement process is expected to be streamlined for the coming year, providing for better coordination with York travel services and ensuring less hardship for our students and more manageable burdens on our human resources.
